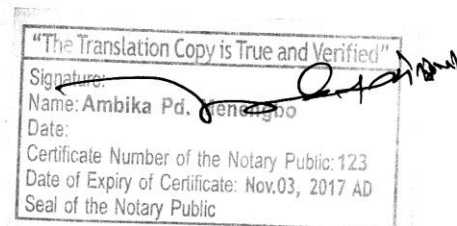

Social Welfare Council, Lainchour, Kathmandu: one copy of tripartite agreement has been sent.

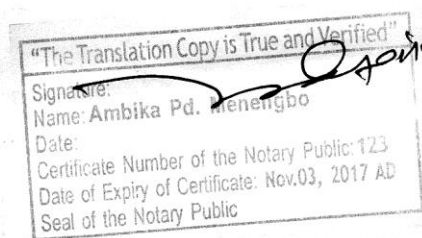
